## Sign-ups Beginning in Camp 8 Road Feeder



Prospective subscribers in the Brewer substation Camp 8 Road feeder are being contacted to sign up in advance of home installation.

Those outside the U.S. Forest land received an email last week and will receive a postcard this week about scheduling their installation.

## Railroad Permit Received

SR Connect received the needed permit for a railroad crossing in George County last week. Not having the permit caused delays in bringing fiber to the Brewer substation pilot project area, but Singing River Electric engineers and information technology staff came up with a solution and relocated equipment from SRE's Lucedale office to the Sand Hill office to bypass the railroad crossing.

With the railroad permit now in hand, the next step is scheduling a flagger to notify contract crews of oncoming trains and any need to clear the railway while bringing fiber across the tracks. This work must take place before potential subscribers in Jackson County's Aleco substation pilot area can receive fiber-to-the-home service.

## **Projected Dates for Fiber Construction**



**Note**: These are *projected* dates and are subject to change due to weather and many other factors involved with starting and completing each step in the process.

#### Pilot Project 1 - Brewer Substation Area

Potential subscribers in the Cochran Road feeder are in Step Seven - Installation.

The Camp 8 Road feeder is completing Step Four - Splicing and entering Step Five - Service Drops.

The Union Road feeder is in Step 3 - Fiber Construction and Step 4 - Splicing.

Note: Bringing fiber to some homes in the Camp 8 Road and Union Road feeders will be delayed until approvals to work on U.S. Forest Service land are in place.

#### Pilot Project 2 - Aleco Substation Area

Work is in Step 3 - Fiber
Construction and should begin Step
4 - Splicing in January 2022.

## Pilot Project 3 - Agricola Substation Area

Work is in Step 3 - Fiber
Construction. Progression to Step 4
- Splicing is expected by February
2022.

## SR Connect Fiber-to-the-Home Pilot Areas

These figures show progress and expressed interest in SR Connect's three pilot areas designated by Singing River Electric substation and feeder.

Singing River Electric's board of directors is monitoring the expressed interests inside and outside of the pilot areas along with scheduled installations in the pilot areas. Based on these results, the board will decide whether to expand fiber service

to other areas and where.

# Why Hasn't SRE's Board of Directors Made a Decision to Expand Fiber Service?

The decision to expand SR Connect's fiber-to-the-home service beyond the pilot

project areas depends on the success of the pilots Once subscribers in all three areas are receiving fiber internet service, the board will be able to gauge their success. It will most likely be 1st Quarter 2022 before the pilot projects are completed, barring no delays.

Contract crews are working safely and quickly to complete construction. This project not only takes time but also a great investment. The SCADA equipment and fiber pilot projects together cost nearly \$9 million. When you add in the fiber distribution ring connecting all SRE substations, offices and the SR Connect pilot areas, it totals more than \$15 million.
